Current Law

- Federal CHIP funds are allotted to states annually
- Under current law, CHIP allotments are only provided through fiscal year (FY) 2017
- Some unspent CHIP funds will be available for spending in FY 2018
 - Unspent FY 2017 CHIP allotments available on October 1, 2017 will be reduced by one-third
 - Unspent allotments from prior years will also be available for redistribution to states with CHIP funding shortfalls
 - Contingency fund payments are not available in FY 2018

CHIP Funding Projections

- FY 2017 CHIP allotments and available redistribution funding are projected to be adequate to cover FY 2017 CHIP spending
- In FY 2018, we estimate that available CHIP funding (\$7 billion) will cover less than half of projected CHIP spending (\$18 billion)
- States will exhaust their federal CHIP funds at different points during the year depending on their rollover balances and projected spending

Implications

- States with separate CHIP are permitted to terminate coverage if CHIP funding runs out
 - MACPAC's prior estimates indicated that about 1.1 million children would become uninsured
- States with Medicaid expansion CHIP must maintain child eligibility levels through FY 2019
 - The federal matching rate for these children falls back from the CHIP enhanced match to the regular Medicaid matching rate

Next Steps

- The timing of congressional action on CHIP is unclear
