Quality measures and data

- Core sets: child and adult, health home, maternity, behavioral health
- CAHPS
- CMS 416 reporting on EPSDT
- Home and community-based services (HCBS) and long-term services and supports (LTSS)
- Section 1115 demonstrations
- Nursing facilities

Quality improvement initiatives

- Maternal health
- Oral health
- Asthma
- Health disparities
- Other initiatives (e.g., obesity, tobacco cessation)
- Value—based payment

Varied performance on core set measures

Primary care access and preventive care					
Cervical cancer screening (CCS-AD)	Α	55.0%	56.1%	55.1%	0.1%
Chlamydia screening in women ages 21-24 (CHL-AD)	А	61.1	60.8	60.2	-0.9
Adolescent well-care visits (AWC-CH)	С	44.7	48.9	50.6	5.9
Developmental screening in the first three years of life (DEV-CH)	С	39.8	42.2	32.7	-7.1

Mixed PIP results

- PIPs should achieve significant and sustained improvement in outcomes and satisfaction
- Mixed results on quality improvement and validation assessment
- Next steps once PIPs end are unclear

EPSDT rates

Percentage of EPSDT eligible children receiving at least one initial or periodic screening service (participant ratio)	0.58	0.59	0.59	0.59	0.60
Percentage of EPSDT eligible children receiving the number of initial and periodic screening services based on state periodicity schedule (screening ratio)	1.00	0.78	0.74	0.78	0.79
